1. Introduction:

- b) **Special Category Scholarships:**
 - i. Fulfillment of criteria set for the specific scholarship category.
 - ii. Satisfactory academic progress.
 - iii. No disciplinary issues on record.

- i. Exceptional academic performance.
- ii. Demonstrated financial need.
- iii. Active participation in co-curricular activities or community service.
