Students must register and fill the application form on the TCS Nextstep portal (if not done already). The status of the student should be "Application Received". This is important to be included in the test process.

**Below is the detailed Eligibility Criteria for the test.**

- **Courses & Discipline:** 2024 Year of Passing Graduates from Arts, Commerce & Science Streams. B. Com, BA, BAF, BBI, BBA, BBM, BMS, BSc (Maths, Physics, Chemistry, Botany, Zoology) from a recognized University / College.
- **Course Types:** Only full-time courses will be considered (part-time / correspondence courses will not be considered). Candidates who have completed their Secondary and / or Senior Secondary course from NIOS (National Institute of Open Schooling) are also eligible to apply if the other courses are full-time.

- **Highest Qualification:** Candidates should have completed the course in the stipulated course duration (i.e., No extended education – 3 years course should have been completed in the stipulated 3 years' time only)
- **Backlogs:** Only one backlog is permitted for the candidates from the 2024 year of passing, however all pending backlogs should be completed within the stipulated course duration.
- **Gap / Break in Education:** It is mandatory to declare gaps in education if any in the TCS Application Form. Overall academic gap should not exceed 24 months until highest qualification. Relevant document proof, as applicable, will be checked for gaps in education.
- **Work Experience:** As this role is for 'Entry Level Requirement', students are not expected to have any prior experience.
- **Age:** Minimum age – 18 years and Maximum age – 28 years

**Last Date to Register - 24<sup>th</sup> November 2023.**

Please note, candidates without reference id's or at registered stage will not be considered for the test.
