Memorandum of Understanding ("MoU")

This Memorandum of Understanding ("MoU") is entered into on Thursday, 24th June,2019 by and between

And

Innerwheel Club of Bombay Kandivli hereinafter referred to as "Organization".

Each of NMFC and the Organization are individually referred to as a "Party", and collectively as "Parties" to this MoU.

In view of the above, the Organization represents and warrants as follows:

- 1. **Purpose:** The purpose of this MOU is to establish a collaborative partnership between the Organization and the NMFC in order to bring positive change in the society and sensitize the students with social issues existing in the country.
- 2. **Duration:** This MOU shall be effective as of the date first written above and shall be exhausted on the mutual agreement of both the parties.
- 3. Governance and Decision Making: Both parties agree to establish a joint committee or working group to oversee the collaboration and make decisions regarding the implementation of the activities outlined in this MOU. The committee will consist of representatives from both the Organization and the NMFC and will meet regularly.
- 4. Confidentiality: Both parties acknowledge that they may have access to confidential information during the course of this collaboration. Both parties agree to treat all confidential information as strictly confidential and shall not disclose it to any third party without the prior written consent of the other party.

- 5. Monitoring and Evaluation: Both parties will collaborate on monitoring and evaluating the progress and impact of the collaborative activities. They will establish a system to measure the outcomes and effectiveness of the collaboration, and share the findings with each other periodically.
- 6. Communication and Publicity: Both parties agree to communicate and publicize the collaboration appropriately, giving due credit to each other's contributions, unless otherwise agreed upon in writing. Any press releases, public statements, or joint publications related to the collaboration shall be approved by both parties prior to release.
- 7. Activities: Both parties agree to undertake the following activities as part of their collaborative efforts:
 - a) Workshops, Seminars, and Training Programs: Conduct joint workshops, seminars, and training programs targeting youth and women to enhance their knowledge, skills, and capacity in relevant areas.
 - b) Community Engagement: Engage in community-based projects and activities that raise awareness on social issues, encourage active participation, and foster a sense of responsibility among community members.
 - c) Health and Hygiene Campaigns: Organize joint campaigns to promote health and hygiene practices, such as sanitation drives, awareness sessions, and distribution of informational materials.
 - d) Networking Events: The Organization and NMFC will organize networking events that bring together girls, female mentors, and successful women in various fields.

8. Roles and Responsibilities:

NMFC will:

- a) Provide access to college facilities, including classrooms, auditoriums, and other necessary feasible infrastructure for joint events and activities.
- b) Share academic expertise and resources to support the organisation's initiatives.
- c) Assist in organizing and coordinating joint programs and activities.

9. Termination:

Either party may terminate this MOU by providing a written notice of termination to the other party of 30 days. Termination of this MOU shall not affect any ongoing obligations or commitments of either party, unless otherwise agreed upon. On termination, each party shall return to the other party all such confidential and proprietary information, documents and reference material of the other party in its possession.

It is agreed that The Organization and The NMFC shall be mutually responsible for the implementation of the aforementioned activities and shall provide any necessary resources or assistance to make the collaboration successful.

This MOU is effective as of the date signed and shall remain in effect until the completion of the activities specified herein.
