This memorandum concerns cooperation and collaboration entered into by Nirmala Memorial Foundation College of Commerce and Science and Laja Talks.



II. Purposes, Scope and General Policies

A. Purposes

This Memorandum aims to create a platform for Female Students, Staff and Teachers of Nirmala college from where they can inspire the society through their stories and ideas.

B. Scope

The general area of interest of the collaboration will include disciplines, primarily at the graduate level, which are of mutual interest.

III. Composition

The collaboration involves the following two principle groups, viz.

- 1. Staff Members and Students of Nirmala Memorial Foundation College of Commerce and Science
- 2. Professional Trainers of Laja Talks

A. Mutual and Independent Responsibilities of Nirmala Memorial Foundation College of Commerce and Science and Laja Talks

- One LAJA Talk session to be held at the Nirmala Memorial Foundation College of Commerce and Science campus every three months, open to students, teaching and non teaching staff.
- There is a process set for it wherein the interested students will submit their draft and the Laja team will work with them, polish them in their public speaking skills.
- Once in six months, LAJA will invite external speakers to speak at the LAJA Talks platform.
- Nirmala Memorial Foundation College of Commerce and Science is responsible for arranging the logistic support in terms of space/venue, seating, audio visual equipment, and audience for the Laja talks.
- LAJA in collaboration with Nirmala Memorial Foundation College of Commerce and Science will provide the certificates for the speakers.
- No financial aid or obligation will be born by Nirmala Memorial Foundation College of Commerce and Science College for any of the Laja Talks.

B. Amendment and Termination of MoU

- This MoU may be amended or modified by a mutual written agreement signed by the representatives of both Institutions.
- This MoU is valid for two years from the date of signing by the representatives of both Institutions. This MoU shall be renewed after being reviewed and renegotiated by both Institutions.
- 3. This MoU may, at any time during its period of validity, be terminated by one of the Institutions upon prior notice to the other in writing not later than three months before the termination date.
