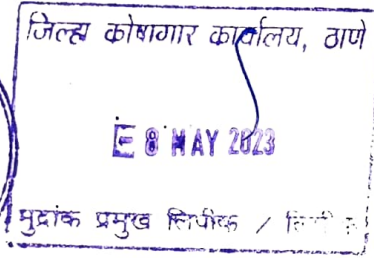

MEMORANDUM OF UNDERSTANDING

This Memorandum of Association has been made and executed at Mumbai on this the Twenty Second day of February, year Two Thousand Twenty Three,

BETWEEN

Two Steps Foundation, a registered NGO under the provisions of Section 8 of the Companies Act, 2013 having its registered office at G6, Padmavati Tower, Balaji Nagar, Bhayandar West, Thane 401101, Maharashtra, India through its Director Mrs. Pooja Dharewa (hereinafter called the party of the First Part or the First Party);

AND

Nirmala Memorial Foundation College Of Commerce & Science (NMF), an educational institute having its campus at 90 Feet Road, Thakur Complex, Kandivali East, Mumbai, Maharashtra 400101, India through the Director of the Institute (hereinafter called the Party of the Second Part or the Second Party or VES).

WHEREAS, the first party is a NGO and is engaged into providing conceptual education to underprivileged sections of the Society under an initiative called "Padhao India". The first party is a charitable organization working towards reducing child dropout rates and improving the learning ability of under privileged kids. Padhao India has found its roots when a child of 6 years, Master Pranit Dharewa started teaching under-privileged kids online during the Covid pandemic.

AND WHEREAS, the party of the second half has been providing education to school and college students.

The management of NMF, strongly believes in community service, collaboration, co-operation and interaction and is hence desirous of establishing the chapter of Padhao India in its Campus.

AND WHEREAS, the first party was desirous of opening a Chapter of "Padhao India" on the campus of NMF to enable the students of NMF to join the cause and become volunteers of their own will and serve the underprivileged sections of the society.

And WHEREAS, the proposal of First Party has been accepted by the Second Party. The Second Party, as such, agrees to open a chapter of Padhao India.

NOW THEREFORE, the aforementioned parties have agreed to the terms and conditions as mentioned hereinafter in order to opening and provide for functioning of the chapter of Padhao India on the campus of NMF;

1. That the Chapter of Padhao India (hereinafter referred to as Chapter) shall work initially for a period of three years which can be renewed further from time to time as per the mutually agreed terms and conditions.
2. That during the first six months the Chapter shall function purely on probationary period, during which period, the activities of the Chapter shall be closely monitored by a Coordinating Committee, as described in clause 4 of this MOU. The Parties agree that, during the probationary period, the Principal of the Institute shall, upon the recommendations of the Coordinating Committee, have full authority and power to terminate the present MOU without assigning any reason in this regards. Conversely, the First Party shall have full freedom to close the Chapter, if it so wishes, after giving fifteen days' notice to the Principal, NMF.
3. That after successful functioning for six months, it will be deemed by Parties that the probationary period has been completed successfully and thereafter the Parties shall be liable to serve at least one month's notice on the other Party before terminating the present MOU.
4. That the Chapter will be fully dedicated for identifying and selecting volunteers for knowledge sharing and teaching young kids from the underprivileged sections of the society. It shall be entitled to demonstrate such, trainings, activities, meetings, conferences, projects, as may be permissible for the Party on the First Part.
5. That the Second Party shall provide necessary approvals and permissions to the students and professors of NMF to take part in the initiatives of Padhao India, which does not affect its own working without any delays. Management of NMF shall allow to set up stalls, put up banners for promotion and creating awareness amongst students about the initiatives of Padhao India. That the Institute shall motivate students to take up volunteer activity under Padhao India.

6. That the First Party will provide all the training, tools and learning pedagogy to the volunteers registered with them. However, the Management of NMF shall be entitled to issue, from time to time, such oral or written instructions to the Chapter coordinators for compliance, as it may, in its considered wisdom, deem appropriate.
7. The chapter may run special training sessions or volunteer sessions from time to time, for which announcements shall be made by e-mail/posting on the Notice Boards
8. That in case of any dispute or differences between the Parties, the decision of the Principal of the Institute shall be final and binding on the both parties. That no new activity shall be undertaken by the Chapter without the prior approval of the Principal of NMF.
9. The MOU places no funding or financial commitments on either Party. Each Party shall be responsible for its own costs under this MOU. In case of any financial commitments, both parties must agree in writing through their authorised representatives.
10. That NMF & Padhao India team shall not be responsible directly, indirectly or vicariously in respect of any act, commission or omission committed by the Chapter volunteers whether on the campus or the repercussion thereof may take elsewhere.
11. That under no circumstances, NMF shall be responsible or answerable for any injury claim, compensation or award of the Court or Statutory Authorities.
12. That the memorandum of understanding may be terminated mutually by both the parties, if required by serving one month notice.
13. In witness whereof the Parties hereto have set there respective hands and signed this Memorandum of Understanding on the day and the year mentioned first.
